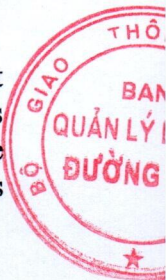

The Government of the Socialist Republic of Vietnam (hereinafter referred to as the "Borrower") has received a loan from the Export-Import Bank of Korea (hereinafter referred to as the "Bank") from the resources of the Economic Development Cooperation Fund (hereinafter referred to as "EDCF") of the Republic of Korea in the amount of KRW 68,171,000,000 toward the cost of the Rehabilitation Project of Section Hoa Duet – Thanh Luyen, Ha Noi – Ho Chi Minh City Railway Line (hereinafter referred to as the "Project"), and intends to apply a portion of the proceeds of this loan to payments under the contract for which this Letter of Invitation is issued.

The terms and conditions of the contract and payments by the Bank, therefore, shall be subject in all respects to the terms and conditions of the Loan Agreement, including the Guidelines for the Employment of Consultants under the EDCF Loan (the Guidelines). Except as the Bank may specially otherwise agree, no party other than the Borrower shall derive any rights from the Loan Agreement or have any claim to the loan proceeds.
3. The Ministry of Transport on behalf of the Borrower now invites proposals to provide the necessary consulting services for the Project. More details on the services are provided in the Terms of Reference (Section 5).

The method of payment will be cash.
